Certified Data Protection Professional-Module G

Prospectus

Cyber Law College is the training partner of Foundation of Data Protection Professionals in India (FDPPI) and conducts training in preparation for the Certification programs of FDPPI.

FDPPI has introduced a Five module skill development program for Data Protection professionals titled "Certified Expert Data Protection Professional" (CEDPP).

The five module included in the program are

1. Module I- Indian Data Protection Laws
2. Module G- Global Data Protection Laws
3. Module-T- Technology for Data Protection
4. Module A- Data Audit
5. Module B- Behavioural skills for a Data Protection Professional

Each of the modules are independent and individual module wise certificates are provided. When the professional acquires all 5 certificates, he will be issued the coveted CEDPP Certificate. Ideally the program is expected to be done in the above sequence though it is not mandatory.

Cyber Law College has already conducted three programs for Module I and one program for Module G. Now Cyber Law College is starting the second batch under Module G as a virtual program commencing from November 7, 2020. One session of 90 minutes will be conducted on every Saturday and Sunday from 11.00 a m to 12.30 pm IST upto December 13.(Subject to minor modifications if program. Successful candidates will be provided the Certifications from FDPPI after an online examination

All the faculty members have substantial hands on experience in Privacy and Data Protection implementation.

Coverage:

The Course objective is to provide the necessary knowledge back up for Data Protection Professionals in India who are typically handling personal data processing not only from India but from many countries in other data protection regions.

Module I has already covered in depth the Indian data protection regime and this Module G will cover the following five major global laws.

- a) GDPR
- b) CCPA
- c) Singapore PDPA 2012
- d) DIFC Data Protection Law
- e) HIPAA
- f) LGPD (Brazil)

Additionally other relevant laws would be discussed during the program based on the requirements.

Who should take this Course?

This course is meant for any person who is dealing with “Personal Data” and includes professionals in IT and non IT companies, legal professionals and students of law in the final year of LLB course or after graduation.

This is an online course in which a series of lectures will be conducted online like a webinar. Students need to attend the webinar through internet either through computer or through mobile as and when the classes are held.

Admission Procedure:

FDPPPI Membership

Foundation of Data Protection Professionals in India (FDPPPI) is a Section 8 company limited by guarantees. It means that it is a not for profit company in the sense that whatever surplus it generates will be used for the objectives of the Company only and cannot be distributed as dividends by the members.

As a Company limited by guarantee, there is no share capital in the Company but members undertake the obligation to contribute an amount upto a maximum of Rs 10,000/- in the contingent event of the Company being liquidated with liabilities being more than the assets. This is only a contingent requirement as per the constitution of the Company. Patron donors are those who have contributed a donation of a minimum of Rs 6000/- .

As regards eligibility of membership, two kinds of memberships are presently accepted. The first is a "Foundation Membership" for donees who contribute Rs 6000. It is like a life membership fee as per the current constitution. The second kind of membership is for donees who pay Rs 15000/-. Such members are called "Supporting Members". Supporting members are allowed to execute joint projects with FDPPPI on a revenue sharing basis subject to the project being approved by the Board on a case to case basis.

International members are those located outside India and they can become members by paying a fee of US\$ 100/- . (Payment can be made only to the Bank account of FDPPPI)

There is presently only one application form for both kinds of memberships and it is enclosed.



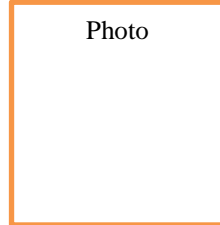
